Mrs. Adams reported the following:

> The previously-approved debris clearing along the fence line was completed in September at a cost of \$2,780. Those areas will be cleared twice each year in conjunction with treatments, as specified in the Lake and Wetland Contract Agreement.

Regarding the conservation area adjacent to old Orange Hole #9, the Verandah Club removed half an acre of vegetation; the five-year monitoring event restoration plan was received by the ecologist on August 30, 2022. Restoration is on hold pending approval by the South Florida Water Management District (SFWMD). Fees are currently estimated at \$19,000 but might increase slightly. If The Club can do all the restoration, it might save a lot of money.

Repair work on Lake H-12/Sanctuary Point will be scheduled in November. Letters will be sent to residents as the date approaches.

Lake H-8A on Cypress Marsh Drive will be budgeted in Fiscal Year 2024.

Asked if storm debris will be removed from the preserves, Mrs. Adams stated it will not.

> During the VECDD meeting it was determined that the HOA is moving forward with fence repair work. The VECDD will attempt to obtain reimbursement from the Federal Emergency Management Agency (FEMA) for portions of fence owned by the VECDD. All perimeter fence in VWCDD is owned by the VCA.

Asked when fence repairs will occur, Mrs. Adams stated proposals were requested but it when the perimeter fence repairs will be done is unknown.

Discussion ensued regarding the limited availability of contractors for small fence repairs.
